# 1. Aims

This policy statement aims to set out our school's arrangements for managing the access of education and training providers to students for the purpose of giving them information about their offer. It sets out:

- Procedures in relation to requests for access
- The grounds for granting and refusing requests for access

Details of premises or facilities to be provided to a person who is given access.

# 2. Statutory requirements

Schools are required to ensure that there is an opportunity for a range of education and training providers to access students in years 8 to 13 for the purposes of informing them about approved technical education, qualifications or apprenticeships.

Schools must also have a policy statement that outlines the circumstances in which education and training providers will be given access to these students.

This is outlined in section 42B of the Education Act 1997.

This policy shows how our school complies with these requirements.

# 3. Student entitlement

All students in years 10 to 13 at Liverpool Life Sciences UTC are entitled to:

- Find out about technical education qualifications and apprenticeship opportunities as part of our careers programme, which provides information on the full range of education and training options available at each transition point.
- Hear from a range of local and national providers about the opportunities they offer, including technical education and apprenticeships, e.g. through activities and events such as options events, masterclasses, PBL, assemblies and taster events.
- Understand how to make applications for the full range of academic and technical courses.

### Meaningful provider encounters

One encounter is defined as one meeting/session between pupils and one provider. We are committed to providing meaningful encounters to all pupils using the <u>Making it meaningful checklist</u>.

Meaningful online engagement is also an option, and we are open to providers that are able to provide live online engagement with our pupils.

#### **Previous providers**

In previous terms/years we have invited the following providers from the local area to speak to our pupils:

- Merseyside Youth Association (MYA).

#### **Destinations of our pupils**

Last academic year our year 11 pupils moved to a range of providers in the local area after school:

- 45% students are studying with us at the CUC6;
- 18% students are studying at City of Liverpool College;
- 5% students are studying at Hugh Baird College;
- 1% students secured an apprenticeship;
- 31% of students are studying at different educational establishments.

Last academic year our year 13 pupils moved to a range of providers after school:

- 84% students went on to study at university;
- 2% students secured an apprenticeship;
- 1% students secured degree apprenticeships;
- 2% students went on to study further at college;
- 3% students secured employment;
- We supported 8% of students in applying for sponsored degrees, apprenticeships and employment.

# 4.3 Granting and refusing access

Education and training providers will be expected to adhere to this policy.

#### 4.5 Premises and facilities

- Any materials left for the students will be left with a member of staff to distribute.
